



# Money Smart Kid 2018 Chicagoland



In support of Chicago's Money Smart Week® for the Chicagoland Area (Cook, DuPage, Grundy, Kane, Kankakee, Kendall, Lake, McHenry and Will), the Federal Reserve Bank of Chicago and its

partner organizations are once again sponsoring the Money Smart Kid Essay Contest. Students in grades 5-8 are encouraged to answer this year's Money Smart Question (see below) with an essay of 300 words or less. Six finalists will be selected to attend the Money Smart Kick-Off breakfast and one student will be named this year's Money Smart Kid, and spend a year as Chicago's financial literacy ambassador. Prizes include a \$3,000 scholarship for the winner and two \$1,000 scholarships will be awarded to the runner-ups sponsored by COUNTRY Financial.

A representative from COUNTRY Financial will present the awards to each of these winners at their respective school. Laptops will also be awarded to the other three (3) finalists sponsored by Woodforest National Bank.

#### Guidelines

Candidates Must:

Be a student in grades 5-8 in their school

■ Have knowledge of money management skills (decision-making related to spending and saving, investing, use of credit, etc.) appropriate for their age and grade level

Demonstrate how they practice good money management skills in their daily lives

■ Be able to "think on their feet" – responding to questions from business leaders and media

■ Be articulate – able to speak in front of large groups and cameras, and respond well to questions

Live in the Greater Chicagoland area

### To Apply

■ Student must be recommended by a teacher using the attached form. (Note: official school sponsorship is not required. Home-schooled children can submit application with parent permission only.)

Student must have parent or guardian permission to apply and participate.

Student must write an essay (300 words or less) on the assigned topic.

Essays must be typed on plain white paper, double-spaced. The Money Smart Kid Application Form must be attached to the essay pages.

The essay must be the work of the student submitting the essay.

■ The application form must be signed by the teacher and a parent/guardian.

■ No teacher may sign more than three recommendations. If doing as a class, submit your three best essays.
